## APPLICATION FOR REFUND of Council Assessment

1. This application must be postmarked no later than 30 days following the date cattle are sold. All applications should be submitted via U.S. Mail to:

2. A copy of the NMLB Form 1 or Bill of Sale or similar instrument establishing that collection of the Council Assessment has been paid must be submitted with this refund application.
3. Applicant's name must be exactly the same as it appears on the NMLB Form 1 or Bill of Sale or similar instrument.
4. Application for Refund form must be signed by applicant.
5. A refund will be paid within 30 days unless the proceeds, the Refund Application Form or the proof-of-payment information has not been received by the New Mexico Beef Council (NMBC). Each form has a unique identifying number.  
**Form may not be duplicated.**
6. Incomplete forms will not be accepted.

7. Agrees, in the event of adequate collect site verification data is unavailable, to cooperate with the NMBC or its agents to provide verification data satisfactory to the NMBC confirming the underlying cattle transaction and payment of the assessment; and,
8. Acknowledges that any refund paid pursuant to this request may be later claimed by the NMBC or its agents or assigns in the event the refund claim was paid due to inaccurate information being provided by the applicant or collection site.

ANY AND ALL CLAIMS ORIGINATING FROM THE SUBMISSION OF INACCURATE OR FALSE INFORMATION IN ORDER TO OBTAIN AN UNJUSTIFIED REFUND WILL BE PURSUED BY THE NMBC TO THE FULL EXTENT OF APPLICABLE LAW.
